Parents / Guardians must be 18 years of age at the time of applying for membership.

In a family membership, it is the sole responsibility of the parent or guardian to ensure the safety and wellbeing of their children (under 18 yrs) at all times.

When children are "on the water" parents / guardians must be kayaking / canoeing / on the water with them during all sessions and trips.

I personally accept all associated risks, and agree to be responsible for my own actions and involvement. I accept that TCC cannot be held liable by me or others for any injuries or damage caused to me, to my possessions - or caused to others or their property by me, due to my participation or involvement with TCC.

I confirm that I can swim at least 25 metres, and am proficient in treading water. I hereby agree to complete any swimming proficiency test upon request of the TCC and will accept their determination as to my proficiency in swimming. I realise that this may result in their refusing me access to join the club.

The club committee reserve the right to refuse membership, or in certain circumstances terminate membership. The annual club membership runs in line with the calendar year. Any person joining midterm must pay the cost of the full annual term.
